ACVO/StokesRx National Service Animal Eye Exam Event Awarded NAVC Veterinary Innovation Council Innovation Award

MERIDIAN, Idaho (March 6, 2018) – At the heels of its 10th anniversary, the <u>ACVO/StokesRx National Service Animal Eye Exam Event</u> program was among the 10 winners of the 2018 <u>Veterinary Innovation Council (VIC)</u> Awards. With five individual categories and five organization categories, this program won in the "Organization: Other" category receiving four out of five votes given in that category; overall more than 180 nominations were up for vote in all categories.

The <u>ACVO/StokesRx National Service Animal Eye Exam</u> is a volunteer-based, philanthropic national event that provides free ocular screening eye exams to qualified Service and Working Animals each May. These exams are provided by 300 board certified veterinary ophthalmologist members of the American College of Veterinary Ophthalmologists[®] (ACVO[®]) who choose to participate and volunteer their time and resources. In 10 years, the program has provided over 60,000 eye exams to deserving Service and Working Animals across the US, Canada and Puerto Rico.

Dr. Brady Beale, past Public Relations Committee Chair and devoted participating ophthalmologist to the program, accepted the award on ACVO's behalf during the award ceremony at the NAVC (VMX) meeting in Orlando on February 4, 2018. In addition, Dr. Beale served as a guest panel speaker at the conference representing and discussing the <u>ACVO/StokesRx National Service Animal Eye Exam Event</u>.
